<u>Monitoring</u>: Permanently monitor and manage critical activities. Periodically review goals, practices, and performance.

Responsibilities:

To fulfill this policy, directors must ensure the availability of resources and the necessary leadership to implement it, while managers and supervisors are responsible for supervising and ensuring that staff and contractors comply with health and safety practices. Moreover, it is crucial for all personnel, contractors, and suppliers to fully comply with the prescribed safety procedures, actively use personal protective equipment, and report any health and safety concerns or incidents.
